I hope this communication finds you in the best of health and spirit. Effective today August 30, 2016 all renewals and extensions of employment packages under the private sector will be returned to your office without my endorsement.

Lately, we have been entertaining the employers in the FSM by renewing their foreign contract workers work permit more than one year as required pursuant to Title 51 FSM Code Section 114. 51 FSM Code Section 114 under "Preference" states that resident workers shall be given preference in employment in the Trust Territory in any industry or occupation for which such workers are qualified and available. Nonresident workers shall be employed to supplement and train the labor force of available and qualified resident workers.

51 FSM Code 152 (2) also states the functions and duties of employment service which is "to conduct continuing surveys of manpower needs, assist in preparing training programs, and recommend other measures for alleviating shortages and reducing the need for nonresident workers."



Kindly convey to the following employers to make necessary arrangements for the following employees to exit the jurisdiction of the FSM no later than 15 days of this notice.
